POSITION SUMMARY:

Assists children in safely crossing streets on the way to and from school in the morning, afternoon.

To perform this job successfully, an individual must be able to perform each essential duty satisfactorily. ESSENTIAL FUNCTIONS:

- Holds stop sign, stopping motorists so children may cross streets.
- Warns children not to cross until the proper time.
- Place street signs in road to reduce motorist speed.
- Guides children across the street.
- Maintains positive relationships with students and staff; models appropriate adult behavior.
- Addresses inappropriate behavior by conferencing with, warning and/or referring students as directed.

MARGINAL DUTIES:

- Other job related duties as assigned by the supervisor.
- Assist other personnel as may be required for the purpose of supporting them in the completion of their work activities.

- Ability to solve practical problems and deal with a variety of concrete variables in standardized situations.
- Ability to effectively present information in one-on-one and small group situations.
- Interpersonal relation skills required.
- Must have basic knowledge of computers.
- Ability to operate specific equipment or tools.

- Must occasionally lift and/or move up to 30 pounds.
- Must have close vision, distance vision, color vision, peripheral vision, depth perception, and ability to adjust focus.
