**POSITION SUMMARY:**

Assist Food & Nutrition warehouse workers with deliveries and warehouse custodial work. Oversee all BBQ events at sites, including delivery, set-up, cooking, tear-down and cleaning.

**ESSENTIAL FUNCTIONS:**

- Assists warehouse workers in receiving items, storing items and delivering items to all district sites.
- Assists warehouse workers in maintaining inventory in the warehouse freezer, refrigerator and dry storage areas. Keeps work area clean and organized.
- Follows standards of safety in storing food. Applies Hazard Analysis Critical Control Points (HACCP) principles.
- Oversees the district BBQ grills; which includes delivery, set-up, cooking, tear-down and cleaning. Keeps all grills clean and ready to use at all times, including filling the propane tanks when needed.
- May substitute in school cafeterias as needed. Must possess knowledge of food safety and sanitation.
- Maintains required forms and records as assigned.
- Demonstrates teamwork through attitude and activities.

**MARGINAL DUTIES:**

- Assists other personnel as may be required for the purpose of supporting them in the completion of their work activities.
- Other job related duties as assigned by the supervisor.

- Demonstrates the ability and desire to provide outstanding customer service.
