POSITION SUMMARY:

Performs a variety of repairs on appliances and equipment inclusive of small refrigeration equipment (i.e. shake machines, portable milk coolers, ice machines, refrigerators, freezers, stoves, ovens, fryers etc.).

To perform this job successfully, an individual must be able to perform each essential duty satisfactorily. The requirements listed below are representative of the knowledge, skill, and/or ability required. Reasonable accommodations may be made to enable individuals with disabilities to perform the essential functions.

ESSENTIAL FUNCTIONS:

- Assists in repairs and reassembling and testing: sweepers, vacuums, scrubbers, polishers, extractors and any related maintenance/custodial equipment.
- Helps repair or replace any faulty parts.
- Helps repair power tools and all makes of hand power tools.
- Cleans and oils appliances as needed.
- Assists in evaluating, evacuates, repairs, and recharges
- Freon of small refrigeration equipment as needed and refrigeration units consisting of five pounds and under Freon capacity.
- Inspects work areas in order to perceive or detect problems, need for repair or maintenance or other factors affecting manual work to be done.
- Assists in repairs and reassembling and testing: kitchen equipment: washers, dryers, mixers, ovens, food warmers, steam ovens, microwave ovens, and broilers
- Assists in operating an engraver to make door signs and name plates.
- Assists in repairs and reassembling and testing: kitchen equipment: washers, dryers, mixers, ovens, food warmers, steam ovens, microwave ovens, and broilers.

- Other job related duties as assigned by the supervisor.
- Assist other personnel as may be required for the purpose of supporting them in the completion of their work activities.

- Ability and desire to provide outstanding customer service.
- Ability to work effectively under time constraints.
- Able to work a flexible schedule which may include weekend work.

- Must maintain a well-groomed appearance.
- Must be a team player and get along well with others.
- Must be highly organized with the ability to multitask.

- Ability to write routine reports and correspondence.
- Ability to add, subtract, multiply, and divide in all units of measure using whole numbers, common fractions, and decimals.
- Ability to compute rate, ratio, discounts and percent and to draw and interpret bar graphs.
- Ability to solve practical problems and deal with a variety of concrete variables in standardized situations.
- Ability to effectively present information in one-on-one and small group situations.
- Must have basic knowledge of computers.
- Interpersonal relation skills required.
- Ability to operate specific equipment or tools.
- Knowledge of general methods and techniques of small appliance repair.

CERTIFICATES, LICENSES AND REGISTRATONS REQUIRED:

- Must have authorization to work in the United States as defined by the Immigration Reform Act of 1986.
- Must have a valid Arizona Driver's License.
- Must not have accrued six (6) points against driver's license within the past three (3) years.

EDUCATION AND/OR EXPERIENCE:

- High School diploma or general education degree (GED).
- Equivalent combination of education and experience.
- Work experience in repair of small motorized and electric appliances helpful.

ADVANCEMENT REQUIREMENTS:

- Must stay at this range for 4 years before being tested for Craftsman Maintenance VII-A/E Repair Specialist II (Range 32).

PHYSICAL DEMANDS:

- Regularly required to stand, use hands to finger, handle, or feel objects, tools, or controls, reach with hands and arms, and talk or hear.
- Must frequently climb or balance, stoop, kneel, crouch or crawl, and taste or smell.
- Must occasionally lift and/or move more than 100 lbs.
- Must have close vision, distance vision, color vision, peripheral vision, depth perception, and ability to adjust focus.

ENVIRONMENTAL CONDITIONS:

- The noise level in the work environment is usually loud.
- The employee frequently works near moving mechanical parts.
- The employee occasionally works in high, precarious places and in outside weather conditions.
- The employee is occasionally exposed to fumes or airborne particles, toxic or caustic chemicals, risk of electrical shock, and vibration.
