POSITION SUMMARY:

Will be trained in the installation, maintenance and repair of locks and other related work. Have general knowledge of methods, materials, tools and equipment.

To perform this job successfully, an individual must be able to perform each essential duty satisfactorily. The requirements listed below are representative of the knowledge, skill, and/or ability required. Reasonable accommodations may be made to enable individuals with disabilities to perform the essential functions.

ESSENTIAL FUNCTIONS:

- Assists in installing and repairs and maintains cylinder and bit key locks.
- Assists in making or cutting keys for cylinder and bit locks, cabinet locks and padlocks; opens locks, changes lock combinations;
- Assists in repairs or replaces tumblers, springs, and other parts.
- Occasionally, as required, performs related installation and repair of door closers, door checks, locksets, casement operators, and door strikes.
- Operates all associated power tools, hand tools as needed for locksmithing.

MARGINAL DUTIES:

- Other job related duties as assigned by the supervisor.
- Assist other personnel as may be required for the purpose of supporting them in the completion of their work activities.

- Ability and desire to provide outstanding customer service.
- Ability to work effectively under time constraints.
- Able to work a flexible schedule, which may include weekend work.

PHYSICAL DEMANDS:

- Must occasionally lift and/or move more than 100 lbs.
- Must have close vision, distance vision, color vision, peripheral vision, depth perception, and ability to adjust focus

ENVIRONMENTAL CONDITIONS:
